

## **Consultancy announcement**

### **Junior Consultant: GWP Transboundary Water thematic support**

#### **1. Introduction**

The Global Water Partnership (GWP) is a Network of more than 3,000 Partners, with 13 Regional Offices, whose mission is to support the sustainable development and management of water resources at all levels. It has been promoting Integrated Water Resources Management (IWRM) since 1996, and is also involved in Climate Change, Transboundary Cooperation, Integrated Urban Water Management (IUWM) and the Nexus approach as well as cross cutting issues such as gender and youth. The consultant will be primarily responsible to provide support on transboundary water portfolio within GWP.

#### **2. Purpose**

The purpose of this consultancy is to support GWP theme on transboundary water with a focus on the development of the Massive Open Online Course (MOOC) on Governance for Transboundary Freshwater Security (see below).

#### **3. Tasks**

##### **a. MOOC on Governance for Transboundary Freshwater Security**

The consultant plays a key role in managing the development of the [Massive Open Online Course \(MOOC\) on Governance for Transboundary Freshwater Security](#). Tasks involve:

- Communicating and coordinating inputs from all the contributors and module coordinators;
- Coordinate video production arrangements;
- Liaison with MOOC platforms;
- Test-run of the MOOC;
- Launch of the MOOC;
- Developing necessary agreements with partners;
- Communication and marketing of the MOOC.
- Any other relevant tasks identified in developing the MOOC

##### **b. Fundraising for GWP transboundary water program**

The consultant will support fundraising for GWP transboundary water program, as well as specific transboundary projects/initiatives within GWP network.

##### **c. Communication materials**

The consultant will support development of communication materials in GWP's the area of transboundary waters.

##### **d. Knowledge products and community of practice**

The consultant will support development of knowledge products and foster community of practice in the area of transboundary waters. In particular, the consultant will support initial development of GWP Africa International Water Law alumni network.

**e. Ad-hoc tasks**

The consultant will assist in any other tasks related to transboundary waters, as well as other areas of GWP's work, upon request by the Supervisor.

**7. Supervision**

The consultant will work under the supervision of Yumiko Yasuda, Senior Network Officer at the GWP Stockholm Secretariat.

**8. Qualifications**

- Master's degree or equivalent in the area relevant to GWP's mission and transboundary water management such as: water & natural resources management, law, or policy.
- Minimum 2-3 years of relevant work experience.
- Project management skills.
- Experience on development of MOOC or education materials is an advantage.
- Knowledge and experiences in the area of transboundary water management is an advantage.
- Good written and oral communication skills with total fluency in English; proficiency in French or Spanish is an advantage.
- E-literacy: Excellent e-skills, including the ability to use modern office technology and related software. Practical knowledge of word processing, spreadsheet, and presentation software is required as well as some web editing skills. Ability to do internet research, compile information and find solutions online to information gaps is essential. Ability to use social media for online engagement.
- Video editing skills and familiarity and experience with online interactive platform is a big advantage.
- Teamwork: Support colleagues, contribute to team culture, and share responsibility for decision-making and results. Places team agenda before personal agenda. Supports and acts in accordance with final group decision; shares credit for team accomplishments and accepts joint responsibility. Ability to "lead from behind" and work without direct authority to deliver timely and high quality products.

**9. Working arrangement**

This consultancy is on part-time basis (up to 50%) until March 2020. There is a possibility of extension depending on the performance and the needs.

The consultant work can be performed either at GWP office in Stockholm or home based. Candidates based in Stockholm will be given preference.
