Scope of the Roundtable

There is a growing recognition of the interconnectedness between Water, Energy, Food and Ecosystems (WEFE), and the need for them to be addressed as a system, based on a WEFE Nexus approach. The international community also recognizes that implementation of the Nexus approach has a potential to provide multiple benefits to society, by supporting the achievement of:

- a) water, energy, food, and ecosystems security through an integrated management of natural resources,
- b) global policy goals, such as Sustainable Development Goals (SDGs), and other goals related to water, energy transition, biodiversity, circular economy, as well as climate change mitigation and adaptation,
- c) enhanced in scope and impact regional cooperation, social cohesion, conflict prevention and peace building, and
- d) economic development, job creation, attracting investments, enhancing innovation and fostering regional economic integration.

At the same time, the Mediterranean region is facing significant challenges related to the availability and quality of natural resources, which generate pressures and related security risks. Moreover, these challenges are growing steadily due to environmental, social, economic, and political drivers (climate change, population growth, lifestyle changes, urbanization, industrialization, migration, and war).

Some significant opportunities are also emerging particularly in the areas of renewable energies, waste water treatment processes and space-related technologies and digitalization.

Such aspects and dimensions were discussed in the 1st Regional Water-Energy-Food-Ecosystems (WEFE) Nexus Roundtable in the Mediterranean on 'Promoting Innovation, Investments and Upscaling of Solutions' that was held on 6-7 June 2023, in Rabat, Morocco) and was attended (physically and online) by more than 160 participants from 15 countries. The main points presented and discussed during the 1st Regional Roundtable, including the presentation files, and a brief Report of the Roundtable, are available [here](#). Representatives of national authorities, stakeholders and regional institutions that participated in the Roundtable agreed on the need for a Strategy for the WEFE Nexus in the Mediterranean's source to sea continuum, to guide integration of policy and management instruments and action lines across sectors to address risks related to water, energy, food and environmental security, capitalize on wise use of emerging opportunities and promote leveraging of necessary funding.

The principal aim of this 2nd Regional Roundtable on the WEFE Nexus in the Mediterranean is to present and discuss the draft Strategy for the WEFE Nexus in the Mediterranean Source to Sea continuum in view of its eventual finalisation and adoption.
