
What is GCF?

- Operating entity of the financial mechanism of the United Nations
 Framework Convention on Climate Change (UNFCCC)
- For long-term finance under UNFCCC for adaptation and mitigation

What is NDA?

- Link between GCF and Zambia
- In the Zambian context- NDA was established by Cabinet Office as the Ministry of National Development Planning under Development Planning Department
- It was operationalized through a Project Office headed by a National Coordinator & Supported by project staff
- The NDA has a Technical Committee comprising of multistakeholder technocrats (state actors from various Govt Department including Gender, non-state actors, and private sector)
- The Technical Committee is chaired by Director Development Planning and the Project Office provides Secretariat.



NDA Operations (Financing)

- To set up the NDA, Government introduced a budget line for its operations which covers emoluments and capital items. This was to enhance country driven process and ownership.
- Financed by both Government and GCF.
- In 2015,GCF- Zambia signed a USD300,000 grant agreement under the readiness programme. However, due to set up teething issues there was a delay to access the funds
- Of the USD300,000, a total of USD60, 000 has been accessed, a request for extension has since been submitted at no extra cost.



Receiving concept notes

- The NDA receives both solicited and unsolicited applications (open through out)
- Ad hock adverts are also done to jump start the country pipeline of projects for submission to GCF
- Concepts are received through the Permanent Secretary-National Development Planning and Administration
- Then submitted to the NDA who in turn prepare Technical Committee meetings by Director Development planning.



Technical Committee Review meeting

 During the review, the committee sees to it that the concepts are in line with the 7th National Development Plan, National Policy on Climate Change and other related Policies and strategies.



Cont.

- A grading system was developed base on the completeness of the concept note in accordance with the GCF Templates and country priorities such as NAMAS,NAPAS,NDC
- Three categories A, B, C and D were developed.

Categor y	Description
A	With minor adjustments, the concept note is ready for submission. The concept note can now be developed to a full proposal for submission. The NDA should write to the proposer to adjust, re-submit and develop the full proposals for the consideration by the NDA committee and a letter of support can be issued.
В	The concept note is good but the NDA needs to interact with the institution on behalf of the committee for adjustments. The NDA is required to give the brief to the committee on the outcome of the meeting for further action by the Committee.
С	The concept note is good but the NDA committee and its experts should interact with the institution and guide on the required adjustments.
D	Proposal does not meet the minimum requirements hence is not acceptable.



Feedback Meetings

- The Technical Committee holds feed back meetings with developers in category B and C
- After the feedback is given, developers adjust the concepts accordingly & resubmit for the next sitting
- TC may some times recommend a verification visit to the site if need be
- The NDA has engaged a consultant to develop rules of procedure which will be helpful in the operations of the NDA including the GCF project preparation cycle
